EXECUTIVE DIRECTOR'S REPORT

Executive Director Jeffers asked the Commission to consider the following resolutions.

RESOLUTION NO. 2017-8

RESOLUTION AWARDING YEAR TWO OF THE MAINTENANCE AND TOLL UNIFORMS TO GRAVES UNIFORMS, LLC.

WHEREAS, the Burlington County Bridge Commission ("Commission") requires a vendor to provide uniforms for its maintenance and toll department employees; and

WHEREAS, bids were solicited by the Purchasing Agent for a contract entitled "Maintenance and Toll Uniforms (BCBC-201601)" for the period March 1, 2016 to February 28, 2017 with an option of a one (1) year extension expiring on February 28, 2018 pursuant to N.J.S.A. 40A:11-16(6); and

WHEREAS, a recommendation from Commission staff identifies the lowest responsive, responsible bidder based on line item grouping, resulting in multiple awards from this solicitation in order for the Commission to receive the lowest price per line item group, awards are contained in other resolutions for the Commission's consideration; and

WHEREAS, Commission staff recommended that the Commission award a contract for Year One (March 1, 2016 through February 28, 2017) to Graves Uniforms, LLC. ("Graves Uniforms") in the amount of \$39,210.50 with the option to award the contract to Graves Uniforms for Year Two in the amount of \$54,401.40; and

WHEREAS, Commission staff has recommended to the Commission that the Commission award the contract for option Year Two to Graves Uniforms, based upon

satisfactory performance during the previous year; and

WHEREAS, the Chief Financial Officer of the Commission has determined that sufficient funds are available for payment for said services, as evidenced by the Certificate of Availability of Funds attached hereto and made a part thereof.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

1. The Commission hereby awards Year Two of the contract titled "Maintenance and Toll Uniforms (BCBC-201601)" to Graves Uniforms, and the Executive Director and the Secretary of the Commission are hereby authorized to execute a contract with Graves Uniforms.

2. The maximum amount of this contract shall not exceed Fifty-Four Thousand, Four Hundred One Dollars and Forty Cents (\$54,401.40) and the contract shall extend for the period March 1, 2017 through February 28, 2018.

Commissioner Singleton moved to approve. Vice-Chairman Fattorini seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-9

RESOLUTION AWARDING YEAR TWO OF THE MAINTENANCE AND TOLL UNIFORMS TO SPECIALTY GRAPHICS, LLC.

WHEREAS, the Burlington County Bridge Commission ("Commission") requires a vendor to provide uniforms for its maintenance and toll department employees; and

WHEREAS, bids were solicited by the Purchasing Agent for a contract entitled "Maintenance and Toll Uniforms (BCBC-201601)" for the period March 1, 2016 to February 28, 2017 with an option of a one (1) year extension expiring on February 28, 2018 pursuant to N.J.S.A. 40A:11-16(6); and

WHEREAS, a recommendation from Commission staff identifies the lowest responsive, responsible bidder based on line item grouping, resulting in multiple awards from this solicitation in order for the Commission to receive the lowest price per line item group, awards are contained in other resolutions for the Commission's consideration; and

WHEREAS, Commission staff recommended that the Commission award a contract for Year One (March 1, 2016 through February 28, 2017) to Specialty Graphics, LLC. ("Specialty Graphics") in the amount of \$38,510.00 with the option to award the contract to Specialty Graphics for Year Two in the amount of Forty-Six Thousand, Four Hundred Ninety Dollars (\$46,490.00); and

WHEREAS, Commission staff has recommended to the Commission that the Commission award the contract for option Year Two to Specialty Graphics, based upon satisfactory performance during the previous year; and

WHEREAS, the Chief Financial Officer of the Commission has determined that sufficient funds are available for payment for said services, as evidenced by the Certificate of Availability of Funds attached hereto and made a part thereof.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

1. The Commission hereby awards Year Two of the contract titled "Maintenance and Toll Uniforms (BCBC-201601)" to Specialty Graphics, and the Executive Director and the Secretary of the Commission are hereby authorized to execute a contract with Specialty Graphics.

2. The maximum amount of this contract shall not exceed Forty-Six Thousand, Four Hundred Ninety Dollars (\$46,490.00) and the contract shall extend for the period March 1, 2017 through February 28, 2018.

Vice-Chairman Fattorini moved to approve. Commissioner Singleton seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-10

RESOLUTION AWARDING YEAR TWO OF THE MAINTENANCE AND TOLL UNIFORMS TO RED THE UNIFORM TAILOR, INC.

WHEREAS, the Burlington County Bridge Commission ("Commission") requires a vendor to provide uniforms for its maintenance and toll department employees; and

WHEREAS, bids were solicited by the Purchasing Agent for a contract entitled "Maintenance and Toll Uniforms (BCBC-201601)" for the period March 1, 2016 to February 28, 2017 with an option of a one (1) year extension expiring on February 28, 2018 pursuant to N.J.S.A. 40A:11-16(6); and

WHEREAS, a recommendation from Commission staff identifies the lowest responsive, responsible bidder based on line item grouping, resulting in multiple awards from this solicitation in order for the Commission to receive the lowest price per line item group, awards are contained in other resolutions for the Commission's consideration; and

WHEREAS, Commission staff recommended that the Commission award a contract for Year One (March 1, 2016 through February 28, 2017) to Red The Uniform Tailor, Inc. ("RTUT") in the amount of \$25,224.00 with the option to award the contract to RTUT for Year Two in the amount of \$24,975.00; and

WHEREAS, Commission staff has recommended to the Commission that the Commission award the contract for option Year Two to RTUT, based upon satisfactory performance during the previous year; and

WHEREAS, the Chief Financial Officer of the Commission has determined that sufficient funds are available for payment for said services, as evidenced by the Certificate of Availability of Funds attached hereto and made a part thereof.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

1. The Commission hereby awards Year Two of the contract titled "Maintenance and Toll Uniforms (BCBC-201601)" to RTUT, and the Executive Director and the Secretary of the Commission are hereby authorized to execute a contract with RTUT.

2. The maximum amount of this contract shall not exceed Twenty-Four Thousand, Nine Hundred Seventy-Five Dollars (\$24,975.00) and the contract shall extend for the period March 1, 2017 through February 28, 2018.

Commissioner Singleton moved to approve. Vice-Chairman Fattorini seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-11

**RESOLUTION EXTENDING THE CONTRACT WITH NETCARRIER
(NO ADDITIONAL APPROPRIATION).**

WHEREAS, the Burlington County Bridge Commission ("Commission") has determined that it requires the services of a firm to provide various voice communication services for the Commission; and

WHEREAS, pursuant to Resolution No. 2011-60, the Commission entered into a contract with NetCarrier to provide these voice communication services; and

WHEREAS, additional voice communication services under this contract are required until the complete transition of all voice service lines from Netcarrier to the new voice communications carrier, and it is therefore necessary to extend the contract to and until the completion and transition of all existing Commission voice lines.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

1. The terms, conditions and duties outlined in Resolution No. 2011-60 appointing NetCarrier are incorporated herein by reference, and for the reasons hereinabove expressed,

the existing contract between the Commission and NetCarrier is hereby extended to and until the completion and transition of all existing voice lines.

2. Notice of adoption of this Resolution shall be published in the Burlington County Times, as required by law.

Vice-Chairman Fattorini moved to approve. Commissioner Singleton seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-12

**RESOLUTION EXTENDING YEAR TWO OF THE POLICE UNIFORMS
AND ACCESSORIES CONTRACT TO LAWMEN SUPPLY COMPANY
(NO ADDITIONAL APPROPRIATION).**

WHEREAS, the Burlington County Bridge Commission (“Commission”) requires a vendor to provide uniforms for its police department employees; and

WHEREAS, bids were solicited by the Purchasing Agent for a contract entitled “Police Uniforms and Accessories (BCBC-201501)” for the period February 1, 2015 to January 31, 2016 with an option of a one (1) year extension expiring on January 31, 2017 pursuant to N.J.S.A. 40A:11-16(6); and

WHEREAS, Commission staff recommended that the Commission award a contract for Year One (February 1, 2015 through January 31, 2016) to Lawmen Supply Company (“Lawmen”) with the option to award the contract to Lawmen for Year Two; and

WHEREAS, pursuant to Resolution No. 2016-9, the Commission entered into Year Two of a contract with Lawmen for the period February 1, 2016 through January 31, 2017; and

WHEREAS, Commission staff is currently reviewing uniform specifications for bid solicitations of a new contract, and finds it necessary to extend Year Two of the contract an additional 3 months until a new solicitation has advertised and been recommended for award.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

1. The terms, conditions and duties outlined in Resolution No. 2016-9 appointing Lawmen are incorporated herein by reference, and for the reasons hereinabove expressed, the existing contract between the Commission and Lawmen is hereby extended to and until April 30, 2017.

2. Notice of adoption of this Resolution shall be published in the Burlington County Times, as required by law.

Commissioner Singleton moved to approve. Vice-Chairman Fattorini seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-13

**RESOLUTION AMENDING THE CONTRACT WITH
INTELLIGENT INFRASTRUCTURE SYSTEMS, LLC.**

WHEREAS, the Burlington County Bridge Commission (“Commission”) has determined that it requires the services of a firm capable of designing and developing an asset management system with implementation tools; and

WHEREAS, pursuant to Resolution No. 2012-93, the Commission entered into a contract with Intelligent Infrastructure Systems, LLC (“IIS”) to provide those professional engineering services, with the work to be performed in an orderly series of phases; and

WHEREAS, IIS has proposed a 4 task proposal for modifications and upgrades to the existing structural health monitoring system of the Tacony-Palmyra and Burlington-Bristol Bridges, it is necessary to increase the contract by an additional One Hundred Eighty-Nine Thousand Dollars (\$189,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

1. The terms, conditions and duties outlined in Resolution No. 2012-93 appointing IIS are incorporated herein by reference, and for the reasons hereinabove expressed, the sum of One Hundred Eighty Nine Thousand Dollars (\$189,000.00) be and hereby is appropriated to pay the fees, expenses and costs for the work associated with the modifications and upgrades to the existing structural health monitoring system of the Tacony-Palmyra and Burlington-Bristol Bridges.

2. Sufficient funds are available for payment for those services as evidenced by the Certificate of Availability of Funds, attached hereto.

Vice-Chairman Fattorini moved to approve. Commissioner Singleton seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-14

**RESOLUTION APPROVING CHANGE ORDER NO. 1 FOR
THE BURLINGTON-BRISTOL BRIDGE (BRIDGE AND
TOLL PLAZA) AND THE TACONY-PALMYRA BRIDGE
(TOLL PLAZA) COMMERCIAL COATING REMOVAL,**

REHABILITATION AND PAINTING PROJECT BCBC-201602.

WHEREAS, pursuant to Resolution No. 2016-50, the Burlington County Bridge Commission (“Commission”) awarded a contract to Allied Painting, Inc.. (“Allied”) for the project titled “Burlington-Bristol Bridge (Bridge and Toll Plaza) and the Tacony-Palmyra Bridge (Toll Plaza) Commercial Coating Removal, Rehabilitation and Painting Project (BCBC-201602)”; and

WHEREAS, the Project Engineer recommended by memorandum dated February 9, 2017 that Change Order No. 1 be approved, providing for the following: costs for the removal of newly discovered asbestos material, and labor and material costs for painting additional, field adjusted canopy square footage at each toll plaza; and

WHEREAS, this Change Order No. 1 requires an increase of \$400,550.51 in the contract price, bringing the new contract total to \$15,086,650.51.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission that, based upon the recommendation of its engineer, and after a thorough review of this matter, the Commission hereby approves Change Order No. 1 for Allied for the project titled “Burlington-Bristol Bridge (Bridge and Toll Plaza) and the Tacony-Palmyra Bridge (Toll Plaza) Commercial Coating Removal, Rehabilitation and Painting Project (BCBC-201602)”.

Commissioner Singleton moved to approve. Vice-Chairman Fattorini seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-15

RESOLUTION AUTHORIZING THE COMMISSION TO PARTICIPATE IN A SHARED PUBLICLY ADVERTISED REQUEST FOR QUALIFICATIONS TO CREATE A SHARED POOL OF QUALIFIED PROFESSIONALS FOR USE BY THE VARIOUS SHARED SERVICES ENTITIES.

WHEREAS, the Burlington County Bridge Commission (“Commission”) places the public trust above all else, and remains steadfast in its commitment to adhering to the highest ethical standards in the conduct of its business on behalf of its users, toll payers, and the taxpayers of Burlington County; and

WHEREAS, in furtherance of those standards, the Commission instituted a competitive quality based, fair and open process for soliciting qualifications and/or proposals for professional services contracts pursuant to N.J.S.A. 19:44A-20.4 et. seq.; and

WHEREAS, the Commission has recurring needs for one or more of the following

professional services including, but not limited to: evaluation and design of roads/highways, bridges, structures, traffic safety, transportation, soils, landscape, geotechnical, planning, land surveying and storm water design and/or management; environmental regulations including Federal, State, and local permitting, environmental analysis, and construction inspection and management and related matters within the purview of the Commission; and

WHEREAS, the Commission has entered into a Shared Services Agreement with the Burlington County Board of Chosen Freeholders (hereinafter "County"), Rowan College at Burlington County, Burlington County Institute of Technology/Special Services School and Burlington County Library Commission (hereinafter "Shared Services Entities") whereby those entities agreed to share services as agreed to by the parties; and

WHEREAS, the Commission desires to utilize a shared publicly advertised Request for Qualifications ("RFQ") to create a shared pool of qualified professionals for use by the various Shared Services Entities for the years 2017-2018 with the County acting as the lead agency for the issuance of the RFQ and the creation of the pool; and

WHEREAS, the professionals selected for the pool shall be required to enter into open-ended contracts by the County, after which each Shared Service Entity may solicit proposals and enter into contracts for specified project assignments as needed by the respective entity.

NOW, THEREFORE, BE IT RESOLVED that the Burlington County Bridge Commission through the Shared Services Agreement authorizes the Burlington County Board of Chosen Freeholders, as lead agency to:

1. Prepare a competitive quality based, fair and open RFQ for professional services pursuant to N.J.S.A. 19:44A-20.4 et. seq. for use by the Shared Services Entities as required.
2. Make said RFQ available at no cost to professionals that desire to provide the required engineering services detailed therein.
3. Publish notice of the issuance and availability of said RFQ.
4. Establish a committee to review responses to the RFQ, which committee shall submit a written report to the County making recommendation as to which professionals shall be included in the Shared Services Pool of Qualified Professional Service Providers for the years 2017-2018.
5. Establish the Shared Services Pool of Qualified Professional Service Providers for the years 2017-2018 for use by the Shared Services Entities.

Vice-Chairman Fattorini moved to approve. Commissioner Singleton seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-16

**RESOLUTION TRANSFERRING OWNERSHIP OF A
VEHICLE TO THE BURLINGTON COUNTY SHERIFF'S
DEPARTMENT.**

WHEREAS, the Burlington County Bridge Commission ("Commission") is the owner of a 2011 Chevrolet Tahoe, VIN #1GNLC2E03BR241436; and

WHEREAS, it has been determined by the Commission that said vehicle is no longer needed for Commission transportation; and

WHEREAS, the Commission has been advised that the Burlington County Sheriff's Department has a need for said vehicle.

RESOLUTION NO. 2017-18

**RESOLUTION TO CONVENE EXECUTIVE SESSION
MEETING**

WHEREAS, the Burlington County Bridge Commission (“Commission”) is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq.; and

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12, provides that an Executive Session, not open to the public, may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Commission to discuss in a session not open to the public certain matters relating to the item or items authorized by N.J.S.A. 10:4-12b and designated below:

- (1) Matters Required by Law to be Confidential: Any matter which, by express provision of Federal law or State statute or rule of court shall be rendered confidential or excluded from the provisions of the Open Public Meetings Act.
- (2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair a right to receive funds from the Government of the United States.
- (3) Matters Involving Individual Privacy: Any material, the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to, information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.
- (4) Matters Relating to Collective Bargaining Agreements: Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.
- (5) Matters Relating to the Purchase, Lease of Acquisition of Real Property

or the Investment of Public Funds: Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.

- (6) Matters Relating to Public Safety and Property: Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.
- (7) Matters Relating to Litigation, Negotiations and the Attorney-Client Privileges. Any pending or anticipated litigation or contract negotiation in which the public body is, or may become, a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.
- (8) Matters Relating to the Employment Relationship: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.
- (9) Matters Relating to Potential Imposition of a Penalty: Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission, County of Burlington, State of New Jersey, assembled in public session, that an Executive Session executive to the public shall be held in the Administration Building of the Commission, 1300 Route 73 North, Palmyra, New Jersey, for the discussion of matters relating to the specific items designated above.

It is anticipated that the deliberations conducted in executive session may be disclosed to the public upon the determination of the Commission that the public interest will no longer be served by such confidentiality.

Vice-Chairman Fattorini moved to approve. Commissioner Singleton seconded the motion. The motion passed unanimously.

MOTION TO RETURN TO PUBLIC SESSION


Commissioner Singleton moved to return to public session. Vice-Chairman Fattorini seconded the motion. The motion passed unanimously.

Chairman Comegno asked for any further business to come before the Commission. Hearing none, Commissioner Singleton moved to adjourn the meeting. Vice-Chairman Fattorini seconded the motion. The motion passed unanimously.
